

- a) It appeared from the Award that (1). Laddu Gopal Bajuria, son of Baidya Nath Bajuria of Ballygunge Circular Road, Calcutta -700019, is the owner of the aforesaid landed property.
- b) The Government of West Bengal made and published a declaration under section 6 of Land Acquisition Act, 1894 (Act I of 1984) published in page 1280(1) of the Calcutta Gazette dated 24/06/1965 being No. 535-L.A.(II) 15/4/1965 and thereby intended to acquire land admeasuring 0.67 acres comprises C.S./R.S. Plot nos. 1726, 1734 and 1725(P) situate at Mouja - Chandanpukur, J.L. No. 02, P.S.- Titagarh, North 24 Parganas, for construction of Telephone Exchange Building at Barrackpore- a public purpose initiative on behalf of the Union of India.


- d) By virtue of the such Award, being final and conclusive the Govt. of West Bengal had taken physical possession thereof vide Possession letter dated 12.12.1973 addressed to Sri R.C. Kundu, L.A. KGO. From T.K. Banerjee, Asstt. Engineer (B/P) CTD, CA
- e) Under section 16 of Land Acquisition Act, 1894, aforesaid landed property was vested in the State absolutely and free from all encumbrances and the said landed property was given possession to the BSNL for construction of Telephone Exchange Building, at Barrackpore, vided letter dated 19.12.1973 addressed to Sri R.C. Kundu, L.A. KGO. From T.K. Banerjee, Asstt. Engineer (B/P) CTD, CA for construction of Telephone Exchange Building, North 24 Parganas.
- f) The said BSNL has been in continuous and uninterrupted possession of the said landed property since 1973. The said BSNL has constructed Telephone Exchange Building and paying taxes and all other outgoings in respect of the said landed property to different authorities.

From the search reports dated 09.11.2021 it appeared that no adverse entries was found in the Index-I and II during the period 1991-2021, as per available records as maintained in the offices of the Additional District Sub-Registrar of Barrackpore, North 24 Parganas, District Sub-Registrar of Barasat, North 24 Parganas and Additional Registrar of Assurances-II and IV, Kolkata.

6. Litigation in respect of the property:

No suit is reported to be pending against the BSNL concerning the said landed property during the period 2010 to 2021 as is evidenced from the Information issued by the office of the Ld. Civil Judge, Junior Division, 2nd Court at Barrackpore and the Ld. Civil Judge, Senior Division, 1st Court both at Barasat.


7. Document based search:

As there has been no registered conveyance in favour of BSNL by the State of West Bengal, there is no scope to conduct document-based search at the concerned registry. Our online verification also reveals that there are no transaction entries that would affect the title of the said landed property. It appeared that the said landed property belong to the Government and the Government has allotted the same to the BSNL and they are stated to be in possession of the same as the absolute owner thereof.

8. Revenue record:

9. It appeared from the L.R. Record that almost entire acquired land 0.67 acres out of 1.27 acres has been mutated and recorded in the name of the BSNL, Kolkata. Some R.S. plots has been renumbered as L.R. plots as contained in the said L.R. Khatian No. 12036. No report from the office of the B.L. & L.R.O. Barrackpore-II, North 24 Parganas is available concerning consolidation of said R.S. Plots to L.R. Plots.

The landed property is also mutated in the records of the Barrackpore Municipality, distinguished as the Premises No. 63(50), Pipe Road, Ward No. 21, and assessment of tax in respect thereof has been made. Copies of the Rent Receipts and Municipal Tax Receipts are enclosed.


10. NOC requirement from State Government for sale of the land:
